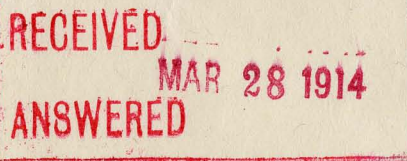

Dear Mr. Mailloux:

I beg to return herewith Professor Crocker's article on "Standardization". Professor Crocker has already read this before our Standards Committee. Our Committee assured Professor Crocker that the opinions he expressed were entirely in conformity with our views, and also that they were in conformity with the resolutions of the *Board of Directors*, laid down for the guidance of our policy. There is, therefore, no conflict of opinion between the views expressed in Dr. Crocker's article and the consensus of opinion of our Committee, so far as I am aware.

I think it is for the Committee on Editing to decide whether the A.I.E.E. Proceedings should print the article; but if they do, there is no objection on the part of our Committee.

Mr. Burke, a prominent member of the Power Club, has been most helpful and active in our revision work this year, and we feel that, with his aid, there is no danger of our infringing upon the premises of that organization.

Mr. Hobart has kindly spent ^{the last} two days ⁱⁿ ~~of~~ solid work here, with Professor Adams and myself, interrupted only by lectures or other essential duties, on the drafting of the new Rules in a preliminary galley form. The expense is going to be heavy, I fear, in the preparation.

Dear Mr. Robinson:-

I enclose herewith an article from Dr. Crocker which it has been suggested that your committee pass upon in regard to publication in the Proceedings. I would state that this article was published some time ago in the Electrical World, and several other technical papers, and has already received rather wide publicity. It also seems to me that as the new Standardization Rules are practically completed, it is somewhat late to take up the consideration of the proper scope of these rules.

If your committee decides to print the paper it seems to me that it would be well to furnish an answer stating that Dr. Crocker's suggestions are entirely in conformity with the Institute's action, and no attempt has been made in the A.I.E.E. Rules to standardize anything beyond nomenclature, methods of rating, and methods of testing.

My dear Mr. Metcalfe:-

I return herewith communication from Dr. Crocker and others which you referred to me under date of April 1.

It does not seem to me that there is any reason why we should print this communication. Dr. Crocker spoke along the same line before the Standards Committee at a recent meeting and I believe his remarks were of great value and were helpful in directing any action which they may take along the right line. In view of this fact and the fact that the communication has been published in many other places I think there would be nothing further gained in printing it in the Proceedings. Also if we print this I donot see why we should not print many other helpful remarks that have been delivered by Mr. Huber, the President of the Institute, the Chairman of the Standards Committee, etc.

I feel further that this general subject is so much more the province of the Standards Committee than of any one else that in the absence of a direct request for publication on behalf of the Standards Committee, it would not be proper for me to suggest or approve of Dr. Crocker's remarks.

I return to you herewith also communication from Mr. R.A. Williams, Secretary of the Electricity Standardization Committee Engineering Society of China.

I donot approve of printing this in the Proceedings at the present time on the ground that it should first be referred to the Standards Committee and might contain suggestions not in accordance with what they would prefer to see carried out in the new rules.
