Dear Mr. MacCutcheon:

In answer to your letter of September 14, we have not found it possible to maintain the Section membership records on any other basis than the official mailing address. Nevertheless, we shall be glad to make an exception to our standard practice so that your change in address for the winter months will not involve a notice of transfer of Section affiliation from Cleveland to Arizona.

Your mailing address is being changed today to Phoenix; unfortunately, the envelopes for the October issue have already been addressed and delivered to the printer, but I trust that you can conveniently arrange for the forwarding of this number to Phoenix.

With reference to your eligibility for Member for Life enrollment, you will receive a notification of such change in status on May 1, 1949, as of which date you will have paid dues for a period of thirty-five years. Although your admission to membership occurred in June 1912, the dues charge was waived for the two years ending April 30, 1919, because of your military service during the first World War. This cancellation of dues accounts for the delay in notification of your enrollment as a Member for Life.
