Whereas, the AIEE and IRE are engaged in the preparation of standards in related or overlapping areas of electrical science and technology, and

Whereas, it is desirable that the efforts of the two societies in preparing such standards be coordinated to avoid duplication of effort and to resolve conflicting standards, and

Whereas, it is desirable that a single standard be submitted to the American Standards Association in fields covered by the two societies,

Be it resolved that the Joint IRE-AIEE Task Group unanimously recommend, to their parent societies that a Joint AIEE-IRE Standards Committee be appointed by, and with the power of, the respective Boards of Directors, and that the Joint Standards Committee be empowered to approve, jointly in the names of the societies, such Standards as the said Joint Committee determines, on its own cognizance, are suitable for joint promulgation, and

Be it further resolved that, on the approval of the above recommendation by both societies, it is recommended that the detailed implementation of the Joint Standards Committee organization and operation be assigned to the existing Ad Hoc Joint Committee on AIEE-IRE Cooperation on Standards.

JOINT STANDARDS COMMITTEE OF AIEE-IRE

1. The name of the committee shall be:

Joint Standards Committee of AIEE-IRE

2. Membership shall include:

- (a) Ten voting members, five appointed by each Institute (these appointees need not be members of their respective Standards Committees).
- (b) A pool of alternates, not over five appointed by each Institute (these appointees need not be members of their respective Standards Committees).
- (c) A non-voting Chairman and a non-voting Vice-Chairman.
- (d) Two non-voting Headquarters staff members, one from each Institute.
- (e) Non-voting liasion members, consisting of all the members of the Standards Committees of both Institutes.

3. Officers shall be:

- (a) A Chairman
- (b) A Vice-Chairman
- (c) A Secretary
- (d) An Assistant Secretary

4. Terms of Office --

- (a) Each officer shall be appointed for a two-year term beginning August 1.
- (b) Each voting member and alternate shall be appointed for a one-year term beginning August 1.
- (c) Any unexpired term of office shall be filled by an appointee from the same Institute as the one being replaced.

5. Selection of Officers --

One Institute shall appoint the Chairman and Secretary. The other Institute shall appoint the Vice-Chairman and Assistant Secretary. Appointment of the Chairman shall be alternated between Institutes.

- (a) Approval of any joint standard shall require an affirmative vote by at least three-fourths of the total voting membership with not less than a majority from each Institute. One or more negative votes in a letter ballot shall require consideration by the Committee at its next meeting.
- (b) In general, the primary responsibility of each member of the Committee shall be to see that the interests of all groups and cognizant technical committees, particularly of his own Institute, have been fairly and adequately represented and safeguarded.
 - (c) The Committee shall promote and encourage joint activities and coordination at working-committee levels during the initial development of standards. They shall take such steps as they deem advisable to effect such closer cooperation and coordination.

11. Modus Operandi of the Committee --

In general, details of operation are to be worked out by the Committee.

- (a) It shall determine when and where to meet.
- (b) It shall determine how much of the work is to be done by correspondence, how much in open meetings.
- (c) It shall write the rules for voting by alternates.
- (d) Meeting notices, agenda and minutes shall be sent to the entire membership as defined in Section 2.
- (e) Copies of proposed standards for approval shall be mailed to all officers, voting members, and alternate members of the Committee, accompanied by a dated letter of transmittal.
- (f) A copy of the letter of transmittal for each proposed standard for approval shall be sent to each liasion member.
- (g) A copy of the proposed standard for approval shall be sent to any liasion member upon his request.
- (h) No proposed standard shall receive final approval sooner than 30 days after the date of its transmittal letter.
- (i) Any liasion member shall have the right to request a delay in approval of a proposed standard for the purpose of conferring with groups having an interest in the Standard. Such requests shall be directed to the Secretary, and shall specify a definite time limit(preferably should not exceed 30 days). If more than 60 days delay appears to be necessary, the extent of the delay shall be negotiated with the Chairman.
- (j) Any voting or liasion member shall have the right, for cause, to appeal any action of the Committee. He shall first direct this appeal to his own Standards Committee, but shall have the right to carry the appeal to his own Board of Directors.

12. Quorum --

A quorum shall consist of a majority of the voting members from each Institute.
