Because of the possible misconceptions given to an uninformed public by the inference that the United States Activities Board is an activity of our national government, we recommend changing the name to the IEEE Activities Board (U.S.).

on the

POLICIES REGARDING THE STANDARDS ACTIVITIES

We have developed a special concern over the basic changes in IEEE practices with respect to its standards activities, and on which the members of IEEE have received no official communication from the Institute's headquarters.

A small item relating to this matter appeared in the IEEE SPECTRUM of February 1976 (p. 23) on "Staff is Cut at Headquarters" (copy attached) without disclosing the effect this cut had on the Standards activities. This only came to published notice in a trade magazine of February 23 under the headline "IEEE Standards Head Quits, Complains About Budget Cuts" (copy attached). This cites the letter of resignation (copy attached) of IEEE's Director of Standards, Sava I. Sherr.

On January 28 the General Manager of IEEE issued a press release (but no notification to the members) announcing that Mr. Sherr would become the Deputy Managing Director of the Energy Program of the American National Standards Institute (ANSI), with the primary assignment of managing ANSI's Nuclear Standards Program and to provide effective interface between ANSI and the primary federal agencies in the energy field.

We consider it a matter of great importance to record a warning against current proposals to abdicate traditional engineering responsibilities in the development and administration of engineering standards by transferring them to a basically commercial standards activity such as the American National Standards Institute (ANSI). This Institute has grown up to coordinate a wide range of commercial products and practices as contrasted with the engineering responsibilities carried by the members of the professional engineering societies.

We believe that if the IEEE leadership continues to undermine the support and morale of its Standards activities, then government agencies will be called upon to take over these activities. As a further indication of current trends to proceed in this direction, we need only to look at a bill recently introduced to the United States Congress, S. 3555 known as "The Voluntary Standards and Certification Act of 1976." This would produce a revolutionary new change in the traditional voluntary standards and certification process in the United States. Some limited opposition has been recorded by the Founder Societies in engineering, and ANSI has registered its opposition to S. 3555 as indicated in the attached report in the September 1976 news item issued by the National Society of Professional Engineers.

The most valuable reference on the history of an engineering standard designed to protect the public safety is recorded in the book

"History of the ASME Boiler Code" published by the American Society of Mechanical Engineers. This Code had its beginning in 1914 and during the past six decades has earned the unbounded confidence of the public as well as of industry and of public and governmental bodies at all levels. This Code stands as the highest example of voluntary services by individual engineers (whose names are all recorded) and who have responded to their ethical commitments to place the public interest and safety above all other considerations. Similar achievements can be cited in IEEE and in its predecessor, The American Institute of Electrical Engineers.

The importance--even the indispensability--to society of those who will identify their ethical obligations in a time of confusion, and act on them, was pointed out by Earl Warren, former Chief Justice of the United States, in a notable address on November 12, 1962:

"Society would come to grief without ethics, which is unenforceable in the courts, and cannot be made part of law. . . . Not only does law in civilized society presuppose ethical commitment; it presupposes the existence of a broad area of human conduct controlled by ethical norms and not subject to law at all. . . .

"The individual citizen may engage in practices which, on the advice of counsel, he believes strictly within the letter of the Law, but which he also knows from his own conscience are outside the bounds of propriety and the right. Thus, when he engages in such practices, he does so not at his own peril--as when he violates the law--but at peril to the structure of civilization, involving greater stakes than any possible peril to himself.

"This law beyond law, as distinct from law, is the creation of civilization and is indispensable to it. . . ."

Recommendations

In the light of these recent developments, the Executive Committee of the Madison Section herewith offers the following resolution for the consideration of the members at the Regional Meeting of Region IV, Area D, of IEEE on November 13, 1976:


Resolved by the representatives of Region IV, Area D, of the Institute of Electrical and Electronics Engineers at their Regional Meeting in Kenosha, Wisconsin on November 13, 1976, that the following recommendations be presented to the Board of Directors of the Institute:

1. That an adequate amount be budgeted to IEEE's Standards Board for substantially strengthening the work and ethical commitments of the Standards Board and of the Institute's members in the development of standards. We believe that standards are an essential and very important part of IEEE's activities and should receive adequate support.


2. That the IEEE Standards Board should report directly to the Board of Directors and its chairman should be a Director and a member of the Board's Executive Committee. This is recommended by Mr. Sherr in his letter of January 26, 1976. It is being proposed by the Technical Activities Board (see copy of notice attached) for action at the next Board of Directors meeting.
3. That the remaining recommendations of Mr. Sherr in his letter of January 26 be considered carefully by the Board of Directors with a view toward strengthening the standards activities of the IEEE.
4. That our dissatisfaction be registered with the Board of Directors for the seeming lack of concern for accountability to the members of the Institute in the above matters. We regret that members are forced to glean news of IEEE affairs from non-IEEE publications without receiving any communication directly. We request that steps be considered to remedy this situation.



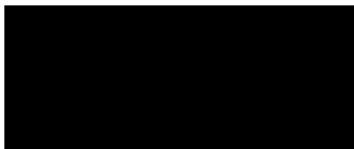

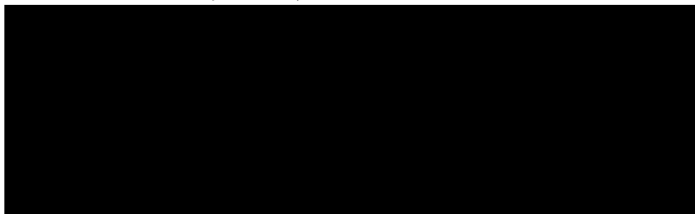
