

Leap Second Meant More Time For June Weddings This Year

"We add an extra second almost every year," says Dr. Sam Stein, chief of the Time and Frequency Division of NBS, who supervises the atomic clocks which provide the standards for time interval and frequency for the United States. "If we didn't, our clocks would gradually get out of step with solar time. Although our atomic clocks are actually much more precise than solar time, they run at a slightly different rate. Since we can't reset the sun, we have to reset our clocks. This keeps the discrepancy between the clocks and the sun to less than one second at all times," Stein notes.

Leap seconds have been used since 1972; there were two the first year, none in 1980, and one in each of the other years. This year, the leap second was added on June 30 at the end of the minute designated 2359 UTC (Coordinated Universal Time). That minute, just before midnight on the Greenwich (England) meridian, contained 61 seconds. At the same instant, clocks all over the world were reset according to instructions from the International Bureau of Time in Paris. In the United States, the moment came just before 8 p.m. EDT.

Only those clocks which must be kept within one second of UTC, such as the atomic clocks at NBS and the U.S. Navy Observatory, are adjusted, so most people were not directly affected by the leap second. It was only important to those who work with very accurate clocks, such as the. operators of communication, transportation, and computer systems.

Television Electronic News-Gathering Equipment Can Be Shut Down

Complaints from the National Aeronautics and Space Administration that spurious radiation from television electronic news-gathering equipment interfered with space shuttle tracking and communications equipment led to a ruling by the Federal Communications Commission authorizing shutdown of such equipment if its operation interferes with other radio communications and in so doing threatens life or property. The ruling met with strong opposition from broadcasting companies.

"Quality" Is Main Problem in Engineering Crisis

The IEEE Board of Directors has approved a position paper on U.S. engineering education that states that the main problem in the engineering crisis is one of quality.

According to the paper, the quality of a large fraction of educational programs is eroding and thereby "limiting our ability to graduate the students who are needed for the appropriate development of the nation's economy, defense, and standard of living."

The paper urges that high quality be given precedence ever increased number of graduates, recognizing that compromises must be made because of limited resources and larger numbers of students.

The paper also offers guidelines for ensuring acceptable quality in engineering programs. These include having appropriate student-to-faculty ratios; limiting the number of students graduated per year to five times the number of faculty; and increasing graduate stipends so they approach 50 percent of the starting salaries of baccalaureate engineering graduates.


