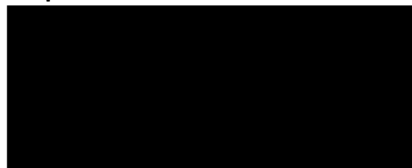

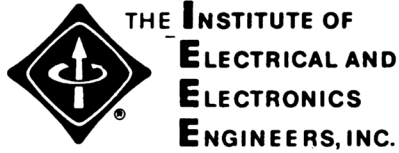

On September 27, 1979, Chairmen of the above-named Sections and the Director of Region 4 met with faculty and students (attendance sheet attached) of South Dakota State University (SDSU). SUBJECT: Council Status for South Carolina

You indicated at our Executive Committee Meeting in Florida that the South Carolina Affiliation is planning to ask for Council status. As you know, there are also steps well underway to forming a Council in Tennessee and North Carolina. Florida has recently formed a Council. Florida and North Carolina generally coincide with the area boundaries of Areas 2 and 4, respectively; however, South Carolina and Tennessee would be Councils that do not coincide with boundaries of existing areas.

I feel there are advantages to the Council concept over the Area and that it provides a means for a more formal structure and for State Councils, a means of handling PAC activities on a State basis. I am, therefore, asking Sully Sullivan to review with his Long Range Planning Committee the whole concept of Councils including the structure of Regional Executive Committee. I would hope that this study could be completed in time to have a report for our October Executive Committee Meeting.

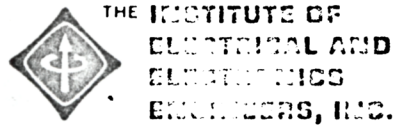
In the meantime, we extend an invitation to Mr. Darby to attend our Regional Executive Committee Meetings.

- A. On January 31, 1972, all concerned approved the petitions requesting a change in status of the existing Subsections of the South Carolina Section to full Sections, as follows:

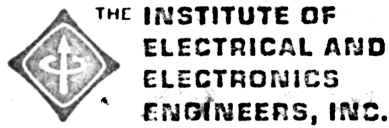

On January 31, 1972, the RAB approved the petitions for the formation of the following four Sections, formerly Subsections of the South Carolina Section.

The territory of the four Sections will be the same as for the Subsections. (All territory of the South Carolina Section was allocated to its Subsections.)

On the same date, the RAB approved the dissolution of the South Carolina Section and simultaneous establishment of the South Carolina Affiliation of Sections, to include the above four Sections. (Former code 03 0 63 00.)

The Coding Department is requested to:

1. Identify all members of each of the above four Sections and code each with the following new Council and Section codes:

The above codings will create the new Sections, and the South Carolina Affiliation. All future changes in the State of South Carolina, and those counties in Georgia now assigned to the Central Savannah River Section MUST contain Council Code 3 for proper identification. (Our records show that there are members on record coded 03 0 63 00 in error. These should also be identified and properly coded to a Section.)


Attached are the petition, a list of the new officers, and the map. The financial statement will be forwarded in the next few days.

The South Carolina Sections of AIEE and IRE held a joint meeting on April 12 and completed the merger at this level. We accomplished this with very good cooperation between the two sections but also with a good deal of confusion. I am therefore writing to find out what, if anything, we have left undone.

It is my understanding that the following information has been sent to you:

1. A petition for establishment of the South Carolina Section of IEEE signed by Vernon Poe for AIEE and me for IRE has been sent via the Region III Director.
2. A list of officers who were elected at the April 12 meeting. They are the following:

The South Carolina Section of the

100. Name

101. This organization shall be known as The South Carolina Section of the Institute of Electrical and Electronics Engineers.

200. Membership

201. All details of Membership including Grades, Rights and Privileges, Qualifications, Applications, Proposals (for Fellows), Admissions and Transfers, Dues, Resignations, and Severances are as covered by the Institute Bylaws, without exception.
202. Relations with, and privileges of, Professional Technical Group Affiliates are set forth in the Institute Bylaws, without exception.

300. Territory

301. The Section shall include in its membership all grades of Institute members residing within the geographic limits of South Carolina, and also those members residing within the following counties of the State of Georgia: Burke, Columbia, Glascock, Jarrerson, Lincoln, McDuffie, Richmond, Talliaferro, Warren and Wilkes.

400. Officers

401. Officers shall be a Chairman, a Vice Chairman, a Secretary, and a Treasurer.

500. Nomination and Election of Officers

501. Not later than the Section meeting next preceeding the Annual Meeting the Chairman shall appoint a Section Nomination Committee consisting of a Chairman and Five members (all of Member grade or higher).
502. The Section Nominating Committee shall contact their prospective candidates and verify their willingness and ability to accept the office, should they be elected, prior to publishing the names of their nominees.

503. The names of the Nominees to be presented to the Section shall be announced at least two weeks prior to the Annual Meeting.
504. Nominations for additional candidates may be made at the annual meeting, but such nominations shall be contingent upon the nominees expressed willingness to serve, should he be elected.
505. Voting for officers at the Annual Meeting shall be by written ballot if more than one candidate has been nominated for that office. Voice or Standing vote may be held if there is only one nominee for an office.
506. Ballot by mail shall be resorted to only if there is no quorum present at the Annual Meeting, or if there is a tie vote of those voting members present at the Annual Meeting.
507. Fellows, Senior Members, Members and Life Members of equivalent grade shall be entitled to vote and hold office, or be chairmen of Standing Committees. Associates shall be entitled to vote but not to hold such office.
508. No Officer shall be eligible for re-election to a succeeding term in his office, except when serving out an unexpired term.
509. Succession: The Vice Chairman shall succeed the Chairman should a vacancy occur. Other vacancies to fill an unexpired terms shall be filled by the Executive Committee.

600. Management

601. The Section Executive Committee shall consist of the Officers, The Subsection Chairman (Ex Officio) and the Chairman of the Section Standing Committees. All Technical Group Chapters shall have representation on the Executive Committee.

700. Committees

701. The Section Chairman, promptly after the Annual Meeting, shall appoint the Chairman of the following Standing Committees.

Program (Meetings and papers) Committee

Membership Committee

Awards Committee

Student Activities Committee

Publicity Committee

702. One Member to each Section Committee shall be appointed by each Subsection Chairman promptly after the Annual Meeting.

800. Meetings

801. The Annual Meeting of the Section shall be held during the month of November each year.

802. The Fiscal Year of the Section shall begin on January 1 of each year.

803. At least 15 Voting members shall be present to constitute a quorum at all meetings of the Section called for the transaction of regular business and requiring a vote.

804. Meetings shall be conducted in accordance with "Roberts Rules of Order".

900. Subsections and Professional Technical Group Chapters

901. Subsection (Geographic) or Chapter (Professional Technical Group) Bylaws are to be subject to the approval of the Section Executive Committee.

902. The Section Executive Committee shall determine the financial assistance to be advanced to each Subsection or PTG Chapter (a portion of the rebates of dues received annually from the Institute). So long as funds are available in the Section Treasury this apportionment shall be decreased only after at least six months advance notice to the Subsections and Chapters.

1000. Amendments

1001. Proposed amendments to these Bylaws shall be submitted first to the Section Executive Committee. The Voting membership shall be advised of the proposed amendment and the recommendation of the Section Executive committee at least three (3) weeks prior to a business meeting of the Section. Approval by two-thirds of the voting members present at such meetings shall be necessary for the adoption of such an amendment.

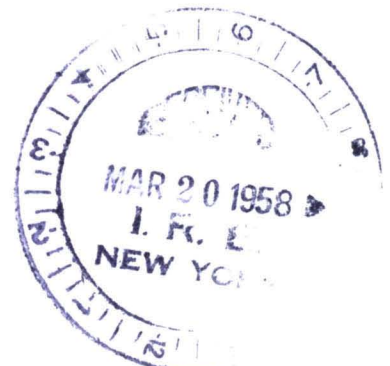

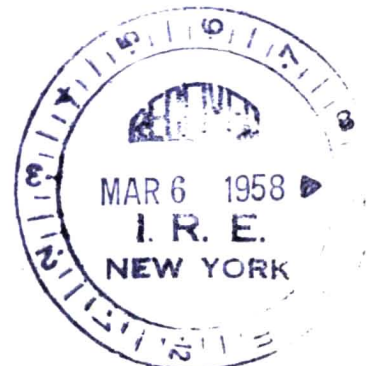

EXTRACT FROM THE CONSTITUTION

ARTICLE IX.

INSTITUTE SECTIONS AND BRANCHES

54. Whenever, in the judgment of the Board of Directors, a sufficient number of Fellows, Members and Associates shall petition, in writing, these members may form, subject to the Constitution and all By-laws and regulations which may be hereafter prescribed by the Board of Directors, a Section organization for the purpose of more effectually carrying out the aims of the INSTITUTE.

EXTRACTS FROM THE BY-LAWS

SEC. 58. A petition for the formation of a Section shall be signed by not less than 25 members residing within the territorial limits hereinafter prescribed. The Board of Directors may decline to authorize the formation of a Section when in its judgment such an organization would not be compatible with the interests of the INSTITUTE.

SEC. 59. In the initial Section organization only petitioners shall have the right to vote.

SEC. 63. The territory of a Section shall include the locality naturally tributary thereto, but shall not include territory so remote or inaccessible that members cannot readily attend meetings. For the purpose of determining the maximum amount to which a Section is entitled under these By-laws, points more than sixty miles from the regular meeting place of the Section shall not be considered a part of that Section, except that, when special conditions warrant such action, additional territory within a reasonable distance may be authorized by the Board of Directors, upon approval of the Sections and Finance Committees. If adjacent Sections are so situated that the sixty-mile limit embraces common territory, the question as to which Section may claim such members as reside within this common territory shall if possible be decided by agreement between the Sections concerned, otherwise by the Sections Committee.

SEC. 64. In addition to INSTITUTE members the Section by-laws may admit other persons interested in engineering, who shall have all the Section privileges except those of voting and holding office.
