SPRING ENGINEERING CONFERENCE

CONFERENCE: An Engineering Conference sponsored by the Cement Industry Committee of the AIEE Industry Division Committee will be held on April 3, 4, and 5, 1962, at the Chase-Park Plaza Hotel, St. Louis, Missouri. The technical sessions will include the presentation of papers on Maintenance and Safety, Power Distribution, Electric Drives, and Automation as related to the Cement Industry. In addition to the technical sessions, arrangements have been made for a Luncheon, Banquet, and an outstanding inspection tour.

CONFERENCE CITY: St. Louis has been chosen as the conference city because of its central location. Airline accommodations to most other cities are good. At this time of year St. Louis should be sprouting out with a few springtime buds. There is much diversification in industry in St. Louis, with two cement plants, several cement terminals, steel mills, chemical mills, a large aircraft factory, several automobile assembly plants, several breweries, and the necessary steam power generating stations.

TECHNICAL SESSIONS: All technical sessions, schoolroom style as last year, will be held in the Khorassan Room on the first floor of the Chase Hotel. The first session will begin at 10:00 A.M., Tuesday, April 3, 1962. Mr. John F. Hower, General Chairman, will preside.

HOTEL RESERVATION: The facilities of the Chase-Park Plaza Hotel are available to the registrants for this meeting. Requests for room reservations should be mailed to the Chase-Park Plaza Hotel, St. Louis, Missouri. The enclosed advance registration and rate card for your hotel accommodations should be used. If the Chase-Park Plaza facilities become overtaxed, they will make reservations for you at nearby hotels. Please make reservations early because rooms at times are scarce.

REGISTRATION: The registration desk will be located on the first floor adjacent to the Khorassan Room and will be open 5:00 P.M. to 9:00 P.M. on Monday, April 2. On April 3 and 4 reservations will be received from 8:00 A.M. to 4:00 P.M. The registration fee will include one bound copy of the Conference papers. The price of the luncheon, banquet, and plant tours will be in addition to the registration fee.

BANQUET: For the last three years, the most popular special event has been the banquet following the technical sessions for all registrants, wives, and guests. It will be held in the spectacular Tiarra Ballroom of the Park Plaza at 7:00 P.M. on Wednesday, April 4. Conference registration is not required for banquet attendance. Banquet Fee — \$8.50.

INSPECTION TRIP: An inspection trip to a very interesting strip mine of the Peabody Coal Company at Freeburg, Illinois, and to the Prospect Hill Plant of Missouri Portland Cement Company has been arranged for Thursday, April 5. The tour buses will leave from the Chase Hotel at 15 minute intervals, starting at 8:00 A.M. and will terminate after both inspections by buses which are routed via the St. Louis Airport, with arrivals scheduled for 3:30 P.M., again at 15 minute intervals: thence to the terminal destination at the Chase Hotel 30 minutes later. A luncheon will be provided jointly by the Alpha, Marquette, Missouri Portland and Universal Atlas Cement Companies. Tour Fee — \$3.00.

HOSPITALITY & INFORMATION CENTER: Ladies will be welcome at any of the Conference activities. Although there is no ladies' program, there are many events in St. Louis to entertain the ladies, from flower exhibits at the St. Louis Botanical Garden to a very interesting local area for window shopping and not far distant, Gaslight Square for evening entertainment.
