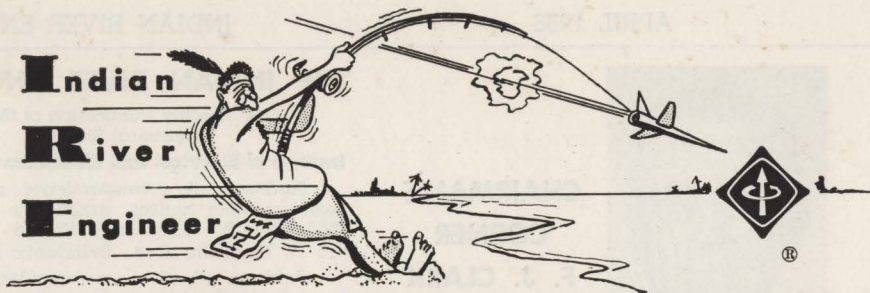

LA VERGNE WILLIAMS, nominee for Chairman, is a member of the Technical Staff at Aerospace Corp. on the Titan III Program. Prior to this he was at Radiation, Inc. on the technical staff of the RF Systems Dept., and as head of the Antenna and Microwave Section.

In February the Canaveral Council of Technical Societies named him "Engineer of the Year" during Engineers' Week activities.

Before joining Radiation La Vergne was an Associate Professor of EE at Univ. of Conn. for 10 years and before that Asst. Prof. of EE at Univ. of Pittsburgh. While with these universities he served as consulting engineer.

He has a BSEE (with highest distinction) from Univ. of Conn., and MSEE and study on his doctoral degree from University of Pittsburgh and Yale. He is the author of a number of papers and holds several patents. He is a Senior Member of IEEE and previously has served our section as secretary and vice-chairman, as well as being active in IEEE nationally. He also is a member of Tau Beta Pi, Eta Kappa Nu, Sigma Pi Sigma, Sigma Tau, and Phi Kappa Phi, and a registered engineer in Fla. and Conn.

GUNTHER KARGER, nominee for Vice-Chairman, has been a communication systems consultant with Pan American Airways since 1965. Before that he was a staff communication system analyst with Radiation, Inc. and

in similar work with ITT. He has served as consultant on several USAF panels in communications network conceptual design.

Gus is presently section secretary and has been active in section affairs. He is also secretary of the Canaveral Communication Technology Group. He served as Professional Groups Coordinator, Editor and Member of the Northern New Jersey Section Executive Committee 1959-1964, co-founded the North Jersey Communication Technology Group and served as its chairman 1963-64. In addition, he is the Editor of the national IEEE Communication Technology Group Newsletter.

He graduated from Louisiana State University with BSEE in 1958 and has several technical papers published. DR. HORST POEHLER is a scientist on the Technical Staff of Pan American Airways, and has been associated with AFETR since 1958. He is concerned with basic scientific problems that affect the Range's ability to meet its ballistic missile and space launch commitments. Dr. Poehler is currently section Treasurer and served for 3 years as Program Chairman.

From 1948 to 1958 he participated in the design of the first Doppler Navigation Systems while employed by General Precision Labs as Section Head. In 1958 he began work with STL at ETR on the solution of missile instrumentation and tracking problems, and published a series of papers on flame attenuation problems.

Dr. Poehler received his BEE degree from Brooklyn Polytech in 1939 and his M. A. and Ph. D. from Columbia University in Pure Science under the Faculty of Electrical Engineering in 1942 and 1948 respectively.

He is a senior member of IEEE and has been active in several national symposia with both IEEE and AIAA, of which he is an Associate Fellow. He is a member of the Health

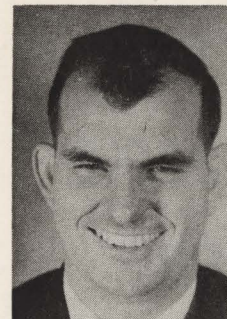
Physics Society, the American Geophysical Union and the Linguistic Society of America.
