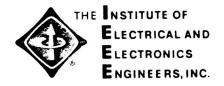

In review of the petition and bylaws by our Vice Chairman of Region III, Reed Thompson and myself, of the proposed Eqlin Subsection, it appears that the petition is an attempt to recognize a type of employment or former employment or association (military) as a grade of membership and coupleing, this as a prerequisite for admission to the proposed subsection. For the purpose of obtaining Eglin USAF base support and use of facilities for Section and Subsection activities. Herein lies the problem, that of obtaining Regional Activity Board approval for the Subsection as it is in conflict in several areas with the Institutes Constitution (revised in December 3, 1977), bylaws of January 1980 and Policy and Procedures Manual, January 1980. Specifically, constitution Article I, Section 2, bylaw number 100 membership, paragraph 101 and bylaw number 400 Geophysical organizations of members, paragraphs 404.4, 404.7, 405.3 and the Policy and Procedures Manual, Section 1.1.

The following is additional details provided by the Vice Chairman of the conflicts noted in the proposed bylaws for the Subsection and suggestions to modify them, if it is the desire of the Section to pursue the establishment of a Subsection.

Proposed bylaw article III, Section 1:

- 11. As written, proposed bylaw article VII, Section 1 will have all Subsection past chairment serving on the Executive Committee. It may be prudent to limit this to the immediate past chairman, or the immediate past two chairman.
- 12. Proposed bylaw article VII, Section 3 should also cite the "Section bylaws" for the Chairman's awareness. Also in this Section 3 there is a protocol error. The Subsection Chairman should represent "the Subsection at all IEEE meetings and shall report to the Section Chairman", not to the Regional Director nor to the Florida Council.
- 13. Proposed bylaw article VIII, Section 2 says, "Letter ballots are to be received at <u>Subsection Headquarters</u>...". It would be more appropriate to have ballots received "by the Chairman of the Tellers Committee who is not personally a canidate for any office being balloted."

As we discussed, I have reviewed this approach with the other Regional Directors to see if possibly there were any similar circumstances in establishing subsections with a Military family concept at the February board meeting. None were identified as having been established along these lines nor did I receive any concensus for support of the other Regional Activities Board Members for such member grade or organizational unit.

As you requested, I have reviewed the proposal documents relating to the formation of the Eglin Subsection of the Fort Walton Section as transmitted with James W. Jones, Jr.'s February 29, 1980 letter to the Field Services Department.

BYLAWS OF THE EGLIN SUBSECTION

Eield Services

ARTICLE I - Name

Section 1 - The name of this organization is "The Eglin Subsection of the Institute of Electrical and Electronics Engineers (IEEE)" and may herein be referred to as the "Subsection".

ARTICLE II - Organization and Scope

Section 1 - The Subsection shall have for its purpose the advancement of the theory and practice of electrical engineering, electronics, radio, allied branches of engineering and of the related arts and sciences, and the maintenance of high professional standards among its members, with special attention to such aims within the territory of the Subsection. The Eglin Subsection is organizationally within the Fort Walton Section.

ARTICLE III - Territory

Section 1 - The "Eglin Sul

Section 1 - The "Eglin Subsection" of the Fort Walton Section is formed to specifically relate to IEEE members who are associated with the Air Force community. The territorial limits for membership in the Eglin Subsection are defined as Okaloosa and Walton counties. Membership in the Subsection is further limited to members of the Air Force family and employees of Department of Defense contractors. The Air Force family includes Air Force active duty military personnel, retired Air Force members, members of the Air Force Reserve components, Air Force civilian employees, and dependents of these groups of people.

ARTICLE IV - Membership

Section 1 - Subsection members are defined as members of all grades of the IEEE in good standing whose mailing address is within Subsection

territory. Privileges, rights, and qualifications of members are described by the Institute Constitution (Article III) and Bylaws (Sections 100-105).

Section 2 - The Subsection Executive Committee may extend the courtesy of notification, Subsection publications and attendance at Subsection meetings to non-members by individual identification. None of the other rights and privileges of Subsection membership will be implied or accorded under any circumstances by this action.

ARTICLE V - Finances

Section 1 - There shall be no Subsection dues. In the event that the Subsection Executive Committee extends courtesies to non-members, the estimated costs of these services may be levied against the membership by action of the committee in meeting.

Section 2 - The Subsection fiscal year shall be the calendar year from 1 January through 31 December.

Section 3 - The financial records of the Subsection shall be reviewed annually by an auditor appointed by the Chairman.

Section 4 - All funds received by the Subsection shall be deposited in bank accounts or invested as approved by the Executive Committee. The signature of either the Secretary-Treasurer, the Chairman, or the Vice-Chairman shall be required for all withdrawals from Subsection accounts.

Section 5 - Revenues will include annual rebates from the Institute, donations, and the Fort Walton Section.

ARTICLE VI - Officers

Section 1 - The officers of the Subsection shall be:

Chairman Vice-Chairman Secretary-Treasurer

Section 2 - The officers of the Subsection shall be elected annually for a term of one year to begin on 1 July. However, the officers will continue until their successors are duly elected and take office.

ARTICLE VII - Management

Section 1 - The Subsection Executive Committee shall consist of the elected officers, the Subsection past chairmen willing and able to serve, the chairmen of the Subsection Standing Committees and such other members as the above listed committee shall elect by majority vote.

Section 2 - Subsection Standing Committees may be:

Program and Publicity Committee Membership and Awards Committee Courier Editorial Committee

A Chairman for each Standing Committee shall be appointed by the Subsection Chairman. Each Committee Chairman shall appoint other members to his committee as required.

Other special committees shall be appointed by the Subsection Chairman as required.

Section 3 - The Chairman shall manage the operation of the Subsection. He shall be familiar with the IEEE Constitution, IEEE Bylaws and the Subsection Bylaws. He shall be responsible for developing and presenting plans to the Subsection Executive Committee. He shall preside at all Subsection and Subsection Executive Committee meetings. He shall represent the Subsection at all IEEE meetings and shall report to the Regional

Director and to the Florida Council of IEEE Chairmen. He shall be responsible for the transfer of Subsection records to the new Subsection Chairman at the end of his term.

Section 4 - The Vice-Chairman shall be responsible for performing the duties of the Chairman in the absence of the Chairman.

Section 5 - The Secretary-Treasurer shall keep minutes of Subsection and Subsection Executive Committee meetings. He shall prepare and submit reports and information to the Institute in the required form and within the required time. He shall collect and, under direction from the Executive Committee, disburse the funds of the Subsection and keep a regular account thereof. He shall submit his accounts to audit when directed by the Chairman or Subsection Executive Committee. This audit is to be performed by an Auditing committee appointed by the Subsection Chairman. The Secretary-Treasurer may be bonded in a manner approved by the Subsection Executive Committee at the expense of the Subsection.

ARTICLE VIII - Nominations and Elections

Section 1 - The Subsection Chairman shall appoint a Nominating Committee consisting of three Subsection members who are not officers, appointing one as Chairman not later than 1 February each year. The committee shall select a slate of nominees for the offices and shall submit this to the Secretary-Treasurer by 1 March for announcement to Subsection membership by 15 March. Additional nominations may be submitted by Subsection members until 1 May.

Section 2 - Elections of officers shall be by letter ballot sent to each Subsection member. Letter ballots are to be received at Subsection Headquarters by 1 June and the results to be announced by 15 June.

Section 3 - The newly elected officers will succeed the current officers on 1 July for a period of one year.

ARTICLE IX - Meetings

Section 1 - No fewer than five regular meetings shall be held during each fiscal year.

Section 2 - Meetings of the Subsection Executive Committee will be called by the Subsection Chairman as needed for conduct of business. A majority of members of the Subsection Executive Committee shall constitute a quorum to conduct its business.

Section 3 - Except as otherwise provided in these Bylaws or in the Institute Constitution of Bylaws, a majority vote of the eligible members present and voting is sufficient to carry a resolution at a regular meeting, but no less than fifteen voting members must be present.

ARTICLE X - Amendments

Section 1 - These Bylaws shall be adopted by a favorable vote of two-thirds of the Subsection Executive Committee.

Section 2 - Amendments to these Bylaws shall be proposed by the Subsection Executive Committee acting upon their own recommendation or a petition signed by at least ten eligible Institute members in the Subsection. A proposed amendment may be approved by a favorable vote of two-thirds of the Subsection Executive Committee, provided notice is sent to Committee

members at least 20 days prior to the date set for the meeting at which the vote is to be taken. Amendments must also be approved by the Base Commander, Eglin AFB, Florida.

ARTICLE XI - Inter-Society Affiliations

Section 1 - The Subsection may affiliate with other groups under policy as stated in the IEEE Section Manual providing the affiliation has been voted on favorably by a two-thirds vote of the Subsection Executive Committee.

ARTICLE XII - DISSOLUTION

Section 1 - In the case that the Subsection is dissolved for any reason, all assets belong to the Institute. If the Institute should refuse to cover any outstanding Subsection debts, each member of the Subsection will be jointly liable.

This letter is in defense of the proposed Eglin Subsection of the Fort Walton Section.

In accordance with Air Force Regulation 34-3, Eglin Air Force Base is willing to charter organizations which support the "military family" associated with the base. The term, "military family" includes all members of the military (active and retired), civil servants, contractors, and the dependents of these. Being "chartered on base" means that Eglin Air Force Base will support and/or assist all organizational activities, such as holding meetings on the base. Since more than seventy-five percent (75%) of our members qualify as members of the "military family", the base facilities provide a convenient meeting place and common communication lines. Those members who do not belong to the "military family" are allowed access to these base facilities for chartered organization activities; in other words, this minority is not excluded in any way. One of the current reasons for having the Fort Walton Section "chartered on base" is to assure base assistance (shuttle buses, visual aids support, etc.) in putting on SOUTHEASTCON '82.

For the last two years all our attempts at becoming so chartered have been refused because the membership of the Fort Walton Section is not limited to the Eglin "military family", despite our assurances that the definite majority of our members did so qualify. This is the sole reason we finally decided to form an Eglin Subsection, restricting membership to the Eglin "military family". The proposed Bylaws of this subsection have already been approved by the Base Commander.

Now we find that IEEE does not approve these Bylaws because of this same membership clause!! How can we please two bureaucracies at the same time? The main argument presented is that the IEEE constitution places no restrictions other than territorial to membership in Sections, Regions, etc. In our case a member moving into our territory would not be allowed to be a member of the Eglin Subsection if he or she did not meet the military family

restriction. But I maintain that restrictions are not unheard of in IEEE. For example, if I move into an area where there is a Student Chapter, I cannot join that chapter unless I'm a student. That is a restriction other than territorial.

I have been pursuing this approach to setting up a subsection since last August. The former Staff Director of Field Services, Bob Asdal, discussed this with me on the telephone on several occasions, even discussing the exact wording of the membership restriction clause. He did not see any problem with it and encouraged me to pursue it since potentially it will improve meeting attendance and ultimately increase membership. I believe that it is simply a matter of attitude - "Okay, let's work something out" vs "Wow, I don't think we can do that."

I recommend that you approve the Proposed Bylaws for the Eglin Subsection which are enclosed. Also enclosed is the petition and Section Executive Committee approval. My office phone is (904) 882-2961.

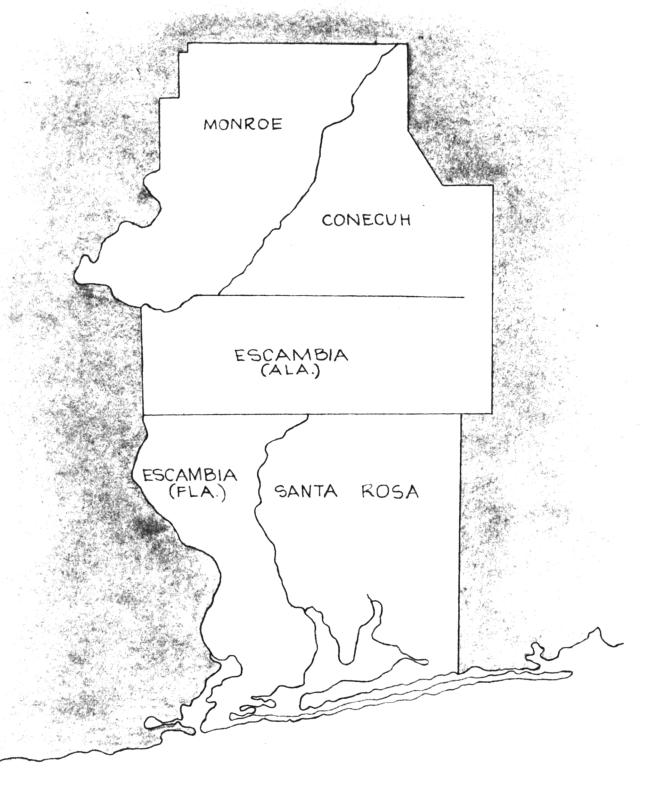
