My dear Hutchinson:--

In a letter to me from Mr. Martindale, Chmn. Membership Committee, he asked me to write to you, "if I am temporarily in financial difficulty".

I am. So, here goes!

Since Armistice Day I have lost all of my sources of income--one after another.-- by fall in prices of my accumulation of mining stocks, and failures to receive dividends, as formerly, from them; etc., etc. These mishaps have brought my nose close to the grindstone.

I will be 83 years of age next 14th. of July. While I have the physical ability to do certain kinds of expert engineering work, age seems to be a matter of consideration with possible employers.

Simply, I am unable to pay my dues to the Institute, at present, at least. But I have promises of employment as soon as financial and other business become better, or normal.

In thinking over my connection with the Institute, from its inception by me in the Spring Of 1884; my labors in getting together the two hundred or more, charter members; and of the continuous attention and work I gave to it during several months of that year; I often wonder why I have never received any formal recognition of my services during the "borning."

Be that as it may:-- I can't pay up now. I am in the hands of the Institute, and, of course, will abide by it's judgment.
