Greetings! I hope all was straightened out with regards to your Sections Congress reservations. Jill Levy informed me that you have requested information on the requirements and steps necessary to split the existing Ozark Section into two Sections, North and South.

Progress of the Northwest Arkansas Subsection, AIEE, as a unit of IEEE

- 1. The Northwest Arkansas Subsection of AIEE was duly created under AIEE Bylaws B 80.031, and the first meeting was held April 9, 1949.
- The Subsection has been a successful and continuous organization as reflected in the records of the Section, District, and General Administration office of AIEE. The officers were listed in the AIEE Organization Manual for the year 1962-63.
- 3. The original Bylaws of the Northwest Arkansas Subsection defined its area only as the vicinity of Fort Smith and Fayetteville, Arkansas. Historically, the Arkansas Section has always published the members of the Subsection as being from Benton, Washington, Crawford, Sebastian, Scott, Polk, Sevier, Howard, Logan, Franklin, Johnson, Newton, Madison, Carroll, Boone, and Marion Counties of Arkansas. Although included in the Subsection membership lists, Baxter, Searcy, and Pope County members were never active as Subsection members.
- 4. Under V (b) of the <u>Principles of Consolidation</u> for IEEE, the Northwest Arkansas Subsection of AIEE <u>has proceeded to exercise its right</u> to "...become in its entirety an equivalent...subsection of the IEEE..." The records show that a list of IRE members embraced in the Subsection area was furnished by the Arkansas Section early in 1963. Correspondingly, these IRE members were added to the mailing lists of the respective Section and Subsection as a step toward consolidation.
- 5. A Bylaws Committee was appointed in 1963 to study and present a revision of the Subsection Bylaws. A revised set of bylaws is in readiness to present to the Subsection for their consideration and adoption, pending approval of the Sectional, Regional, and National reviewing bodies.
- 6. The officers for 1963-64 were elected in accordance with the present Subsection Bylaws. Mr. W. J. Buche, a former IRE member, was elected Secretary-Treasurer of the Northwest Arkansas Subsection. The election of these officers was reported to the General Manager, IEEE, and other appropriate offices following the May 17, 1963, meeting of the Subsection:

- 7. Stationery, report forms, and a cut of the insignia of IEEE were obtained from the General Manager for the use of the Subsection. The April 26 and May 17 meeting reports were made on new approved forms bearing the insignia of IEEE.
- 8. Other than the above mentioned correspondence and reports, no official report of the formation of a Northwest Arkansas Subsection was made to any office. It appears the Arkansas Section advised Mr. H. O. Hodson, Director Region 5, on July 3, 1963, of the formation of an Arkansas Section, IEEE, and the counties which comprised it. The counties named in Paragraph 4 of this report have not been checked for conflict against the list of counties comprising the Arkansas Section, IEEE, at the time of writing. It is expected no conflicts exist omitting Baxter, Searcy, and Pope Counties from the Subsection area.
- 9. The Northwest Arkansas Subsection learned of a question of its legality as a Subsection IEEE in correspondence with the General Manager August 20, 1963, and subsequent correspondence. The Subsection at present is continuing to function as a unit of IEEE, pending advice of the parent Arkansas Section.

This report hereby requests formal recognition of the present existence of the Northwest Arkansas Subsection, IEEE.



On 3 July you addressed a letter to me which was received 29 July. This letter advised me of the formation of the Arkansas Section, I.E.E.E. Your letter did not mention the possible formation of a Northwest Arkansas Subsection. Accordingly, I only advised New York Headquarters of I.E.E.E. that an Arkansas Section had been established and defined the countles which comprised it.

An audit of the finances dated July 17, 1963, showed a balance of \$222.65 for the beginning of the 1963-64 fiscal year for the Northwest Arkansas Subsection.

The Northwest Arkansas Subsection shall submit a constitution and bylaws to the Arkansas Section, Regional, and National offices for approval at the earliest possible date. The new organization is a cooperative effort of all former AIEE and IRE members involved.
